

DRIVE-RIGHT **SCHOOL OF DRIVING, INC.**

TWO YEAR CONTRACT FOR DRIVER'S EDUCATION AT HONONEGAH HIGH SCHOOL 2020-2021 and 2021-2022 SCHOOL YEARS

In exchange for the fees outlined below, DRIVE-RIGHT School of Driving, Inc. agrees to instruct students of Hononegah High School in a driver education course. This course will consist of 6 hours behind the wheel and 6 hours of observation.

COST OF COURSE PER STUDENT:

The contract reflects the first fee increase in 4 years with Hononegah High School. The fee is \$330 for behind-the-wheel to be paid by the school district. This fee does include a \$60 discount for taking behind-the-wheel with the high school.

If the student does not complete the behind-the-wheel requirements, Hononegah High School will be billed a \$50 fee for each drive the student does complete.

BEHIND THE WHEEL:

Once the classroom portion starts and the students get their permits, we will be in contact with the students to arrange driving times. Driving times are available during the school day, after school, and on weekends. Scheduled drives will begin and end at Hononegah High School. Students will receive 6 hours of driving and 6 hours of observation.

DRIVER EDUCATION:

Drive-Right agrees to offer and provide driver's education classes to Hononegah students on Hononegah High School's campus. Drive-Right shall be solely responsible for planning and presenting the driver's education requirements imposed by the State of Illinois. Drive-Right shall provide all necessary teachers and substitutes. All driver's education teachers or substitutes shall be considered employees of Drive-Right and not employees of Hononegah High School.

TERMINATION:

This agreement may be terminated by either party, without cause, upon one semester's advance written notice, which must be given prior to the beginning of the semester to be effective at the beginning of the following semester.

TIMES AND LOCATION:

Times and locations will be mutually agreed upon between both the school district principal and DRIVE-RIGHT School of Driving, Inc.

HANDICAP PROVISION:

If any student is in need of handicap controls, pedals etc., the Hononegah School District will be responsible for the cost incurred. These costs include but are not limited to the purchase of necessary equipment, installation and removal of handicap devices.

COVID - 19:

Due to the fluid nature of ever changing policies, recommendations, guidelines, etc. all matters are subject to change in reference to the Covid-19 Pandemic. Please see attached guidelines for Drive-Right School of Driving from the Secretary of State.
