	deliveries in a timely manner. Cintas corporation currently supplies the
	district with defibrillators and can provide cleaning supplies, restroom
	supplies, and first aid products. Cintas will replace and standardize
	bathroom fixtures as there are many different ones in the building and also
	provide one key to open all the dispensers. The committee recommended
	this item be placed on the November 16, 2022 agenda for approval.
Kwik Star Development	Mr. Dugan reported Kwik Star (Kwik Trip in WI) wants to build a gas
	station on the corner of Route 75 and Manchester Rd. Hononegah CHSD
	#207 and Prairie Hill CCSD #133 will draw up a tax abatement resolution
	of 50% for 5 years which he will bring to the December 21, 2022 for
